WPMC 2020 Officers & Board

President - Cecily Franklin

Cecily will serve her third and final year as President. She has previously served on WPMC's Board as Recording Secretary, Corresponding Secretary, and Vice President. Vice President - Ann 'Fluff' Berger

Fluff joined the WPMC Board in 2014 and has served in various Secretary positions prior to being elected Vice President. Fluff is also an official WPMC Identifier and chairs the Education and Lincoff Foray Committees. In 2017 she won WPMC's President's Award. This year Fluff led walks at Devil's Hollow, Sewickley Heights Borough Park, and Audubon Greenway. She was a speaker on Mushroom Education Day and gave presentations for the local chapter of the National Ladies Homestead Gathering and Juniper Village senior community in Forest Hills. She assists in identifying mushrooms at the monthly meetings, after walks, and at the annual Lincoff Foray. Known for her mushroom photography, Fluff's photos have been featured on WPMC promotional materials and on the websites of WPMC and Michael Kuo, as well as Mushroom Observer and iNaturalist.

Secretary - Adam Haritan

Adam joined the Board in 2016 and has previously served as both Corresponding Secretary and Vice President. He is also an official WPMC Identifier. This year Adam led a walk at Hartwood Acres and organized all of the morning walks for the Lincoff Foray, where he was a featured speaker. Outside of WPMC, Adam teaches classes and workshops on topics including foraging, plant ID, tree ID, and mushroom ID. This will be La Monte Yarroll's final year as WPMC's NAMA Trustee, completing the second year of this second term. As NAMA Trustee, La Monte prepared a report on WPMC's activities prior to NAMA's annual foray and wrote an article for WPMC's newsletter following the Foray. La Monte is also active on NAMA's Mycoflora 2.0 project and, at this year's WPMC meeting in June, he gave a presentation on the work of the Mycoflora Committee.

In 2017, La Monte received WPMC's Outstanding Service award. This year, he spoke at WPMC's Mushroom Education Day and assisted Allegheny Land Trust with its PA Master Naturalist training. La Monte organizes WPMC walks and has led many this year, including Sycamore Island, Keystone State Park, Schenley Park and Chatham University. WPMC Keeps Setting New Records for Membership

Pre-Foray Walk at Cook Forest

WPMC HOSTED ITS annual pre-foray walk at Cook Forest State Park on September 20, a tradition initiated by Gary Lincoff in 2015. Considered to be among the most distinguished natural areas in western Pennsylvania, and protected in perpetuity from extensive development, Cook Forest features towering stands of old-growth white pine and eastern hemlock trees located above and along tributaries that feed into the Clarion River.

Since Gary's passing in 2018, the pre-foray walk has continued with the support of WPMC Mycologist **Garrett Taylor** and park environmental education specialist **Dale Luthringer**, along with the help of numerous WPMC members and identifiers.

This year's outing attracted several dozen mushroom enthusiasts (including a few Colorado residents!) to the forest in search of early autumn fungi. While conditions had been relatively dry compared to previous years, club members collected within a few hours a total of 154 species. This number included 126 species that were already on the club's life list, 24 species new to the list, and four specimens identified to genus level. To the delight of many collectors, among the mushrooms found were seemingly endless amounts of Yellowfoot Chanterelles (*Craterellus tubaeformis*)—an edible *mycorrhizal* species that, despite having "Chanterelle" in its common name, is taxonomically placed within the Black Trumpet genus (*Craterellus*).

Members who walked with **Dale Luthringer** were treated to fascinating and detailed accounts of old-growth trees located along Tom's Run within Cook Forest. Dale's extensive work involving trees within the forest, along with his passion and dedication to conservation, contribute immensely to the health of Cook Forest and likewise to the execution and success of WPMC outings.

Moving forward, Cook Forest State Park—with its unique plant communities, geological features, and conservation strategies will continue to be a repository of interesting fungal species. As part of its mission to promote the enjoyment and study of wild mushrooms, WPMC will help to collect, document, and bring awareness to these often-overlooked fungi considered by Gary Lincoff to be the true "workhorses" of Cook Forest.

Foray Exceeds Expectations

EXPERT SPEAKERS—**Bill Russell** showed us several unexpected and delicious edible fungi, **Rick Kerrigan** talked about the world of Agaricus fungi, and WPMC Identifier **Adam Haritan** educated us about the medical applications of some of fungi's most dangerous poisons.

FABULOUS FOOD—WPMC Mycologist **Kim Plischke** and Treasurer **Barb DeRiso** orchestrated the foodie symphony, supported by many other members who brought in harmonious dishes. What we called a "light lunch" was a delicious variety of homemade soups, dips, and finger foods, many featuring wild mushrooms. As always, WPMC's Mushroom Feast was an adventure into the tastes and textures of wild fungi prepared in a multitude of ways. And for dessert, fabulous Chanterelle Ice Cream!

AUCTION—We actually stopped accepting auction items a few weeks before the Foray, since we had such a plethora of interesting, fun, and useful things. Congratulations to all the winners!

Finally, we are eagerly looking forward to next year's Foray, WPMC's 20th anniversary celebration, scheduled for September 12, 2020. We've already booked **Michael Kuo**, creator of MushroomExpert.com and author of several engaging books on fungi. Quinoa and Urad Dal (Lentils) with Mushrooms

INGREDIENTS

1 cup whole urad dal (lentils), soaked 6-8 hours, drained and rinsed

- 1 cup quinoa
- 3 cups water
- 2 cups veggie stock
- 2 tsp. salt, or to taste
- 2 tbsp. olive oil
- 1 large onion, sliced
- 4 cloves garlic, minced
- 1 red bell pepper, sliced
- 1 lb. mixed mushrooms, diced or sliced in bite-sized pieces
- 1 1/2 cups diced fire-roasted tomatoes (or 15 oz. can)
- 1/2 cup mixed fresh herbs, sliced and packed

(I used Vietnamese fish mint which has a nice rich flavor, along with Thai basil, parsley, lovage, thyme, rosemary, and cilantro, or use whatever you prefer.)

THIS DISH WAS INSPIRED by the scarcity of any good quantities of wild mushroom species in the entire northeast in the Fall of 2019, the whole year really. I chose to make a dish that would use whatever mix of mushrooms I had on hand. My cooking crew(s) and I successfully executed it the first time with a mix of *Cortinarius caperatus, Suillus weaverii (granulatus)*, and *Boletus edulis*, and also with mixed *Grifola frondosa* and *Laetiporus sulphureus*. The first time we made it we left the Urad Dal (lentils) slightly undercooked, not so much that it stuck in teeth or tasted raw, just so it had some integrity. This added a nice texture to the final dish that I tried to replicate in this recipe.

INSTRUCTIONS

1. In a large stock pot, add soaked and rinsed lentils, water, stock, and 2 tsp. of salt and bring to a boil. Lower the heat to a simmer and then cook partially covered for 10 minutes. After 10 minutes, stir in the cup of quinoa and return to a boil while continuously stirring, turn down to a simmer, and cook for 15 minutes or until everything is just under done.

2. While dal is cooking, add 2 tsps. of oil in a large skillet over medium heat, and add the bell pepper. Sauté for 7-9 minutes, stirring often until wilted, remove from pan to a dish. Add the remaining 4 tsp. of oil and add the mushrooms and cook until they give up all of their liquid. (Add quicker cooking mushrooms towards the end so it doesn't get soupy.) Add the onions and peppers and stir to deglaze. Cook until all the liquid is evaporated. Add the garlic and sauté an additional 1-2 minutes. Remove from heat. (If you have a lot of liquid at any point, consider tipping it off into the cooking dal and quinoa.)

3. When the lentils are soft, add the tomatoes and the mushroom/onion/pepper mixture. Cook five more minutes. If at any point it gets too dry, you can always add more water.

4. Add salt if desired. Stir in the half cup of fresh herbs.

Following a screening of the documentary "The Kingdom: How Fungi Made Our World", Cecily and Fluff answered questions about WPMC and about mushrooms in general.

Western Pennsylvania Mushroom Club Release and Indemnification Agreement

This Release and Indemnification Agreement (the "Agreement") is entered into by and between the Western Pennsylvania Mushroom Club, as it is presently organized and may be later structured ("WPMC") and the undersigned Member (the "Member") on this _____ day of _____, 20_____.

WHEREAS, WPMC is a non-profit educational organization that has as its principal purpose the sharing of mushroom-related information among its members; and

WHEREAS, all officers, directors, identifiers and members serve WPMC in a voluntary capacity and receive no remuneration for their services; and

WHEREAS, in cases where WPMC charges a fee for its forays, walks, lectures and other events (collectively "WPMC Events"), it is doing so only to cover its direct costs and does not operate in a for-profit capacity; and WHEREAS, the Member understands that there is inherent and unavoidable risk in outdoor activities relating to hunting and consuming wild mushrooms. These risks include but are not limited to the dangers of hiking in difficult terrain, the possibility of misidentifying a wild mushroom, and the possible allergic or toxic reaction that some individuals may have to otherwise edible mushrooms.

NOW THEREFORE, the Member hereby agrees to the following:

- 1. The Member assumes all risks associated with WPMC Events. The Member expressly acknowledges that it is the Member's sole responsibility to hike safely and to determine whether a wild mushroom may be consumed.
- 2. The Member releases, holds harmless, and indemnifies the WPMC, its officers, directors, identifiers, and representatives from any and all liability relating to any injury or illness incurred by the Member or the Member's family members as a result of participation in a WPMC Event.

This Agreement shall be governed by the laws of the Commonwealth of Pennsylvania. If any portion of the Agreement is declared for any reason to be invalid or unenforceable, such invalidity shall not affect any other provision of the Agreement. This Agreement shall apply to all current and future WPMC events.
